Trail Challenge Clinic on Friday, June 12, 2009. 12:00 P.M.

**Location:** Whitetail Ridge Arena is located at 3962 Campbell Lane, New Meadows, Idaho. From highway 55: Turn North on Cemetery Road, (Cemetery Road is 1 mile east of New Meadows on highway 55) follow north 2 ½ miles to Farrell Lane turn left, follow ¾ mile to Campbell Lane, turn Right, continue north 2 miles to 3962 Campbell Lane. Turn right through the gate, follow gravel road up the hill. From the North, highway 95: Turn Left at the “Zims Hot Springs” road sign. This will be Circle C Lane. Follow east to Campbell Lane, turn right, go approximately 2 miles to 3962 Campbell Lane. Turn left through the gate, follow gravel road up the hill. Note: the first ¼ mile of driveway is private property, please drive slowly and do not park or block the roadway.
